# The Guernsey-Muskingum Electric Cooperative Scholarship in honor of Jerry Kackley



In 1980, Jerry Kackley, a high school senior at Meadowbrook High School, won the Guernsey-Muskingum Scholarship. At the time, each high school in the GMEC territory could nominate one boy and one girl to compete for the scholarship. Who knew that 12 years later, Jerry would become employed by GMEC and eventually become general manager/CEO? In 2018, Jerry was diagnosed with cancer and in early 2019, made the decision to retire to spend time with his family.

Shortly before Jerry passed away, he and his wife, Debbie, decided they needed to give back to the GMEC members who supported him and his family through the years. This

led to the creation of the Guernsey-Muskingum Electric Cooperative Scholarship in Honor of Jerry Kackley. Jerry's family, with the help of the Muskingum County Community Foundation, has created a \$750 scholarship to honor Jerry.

To be eligible for the GMEC Scholarship in Honor of Jerry Kackley, you must be a senior with a 3.0 GPA or higher whose parents/guardians are members of Guernsey-Muskingum Electric Cooperative. ## Energy Efficiency Tip of the Month

**Replace standard power strips with advanced power strips to save energy.** Advanced power strips look like ordinary power strips, but they have built-in features that are designed to reduce the amount of energy used by standby electronics that consume energy even when they're not in use (also known as phantom load).

The National Renewable Energy Laboratory (NREL) estimates that the average home loses \$200 annually to energy wasted by phantom load.
